Dear Election Officials,

I received a notice in the mail (see next four pages) around 8/31/2024 at my mailing address, PO BOX 170058 , Atlanta, GA, 30317.

The notice says that because election mail has been returned from this address as “undeliverable,” we might have moved and I have 30 days to contact them or I will be moved to “inactive” status!

We have lived in the same house and had the same PO BOX for two years. Both addresses are correct in MVP.sos.ga.gov. I am already listed as “inactive”, even though only a week has passed since my receiving the notice. I tried but failed to “update” the address. (See last two pages) My next step is a phonecall.

Not only have we lived here for two years, but we’ve been registered to vote here for two years AND have voted FOUR times in the local precinct, also listed correctly in.mvp.sos.ga.gov.

This is very alarming, considering the known extensive problems with USPS over the last year or so. Presumably I will be able to get myself reinstated, but I am extremely concerned about how many other people will be surprised by their inability to vote this November.
